Membership Types	Membership Type Requirements
Individual	Must be 18 years of age or older, in good standing with the American Kennel Club, and subscribe to the purposes of this club. Individual members are allowed to vote and hold an office or chairmanship in the club. Two meetings must be attended within a six-month time frame to be eligible for this membership type.
Family	Same as individual membership type, but extends to any two members of a family, each to have voting privileges and allowed to hold an office or chairmanship in the club. Two meetings must be attended within a six-month time frame, by each family member, to be eligible for this membership type.
Junior	Must be between 10 and 17 years of age. Junior members hold no office or chairmanship, and are ineligible to vote. When they attain their 18th birthday, they shall become either an individual or associate member.
Associate	Associate members shall consist of individuals who support the goals, purposes, and activities of the club. They shall be entitled to receive the club's newsletter and to participate in club activities. Associate members hold no office or chairmanship, and are ineligible to vote.
Honorary	Honorary members shall consist of individuals who have held an individual or family membership for a minimum of 15 consecutive years and 10 additional years as an individual, family, or associate membership. Honorary members will not pay yearly dues and are ineligible to vote.

\$25 Two adults in a household	One of the following options: 1) Family Membership Type (2 people) 2) Individual Membership (1 person) and Associate Membership (1 person) for a total of 2 people 3) Associates (2 people)
\$20 1 adult in a household	One of the following options: 1) Individual Membership (1 person) 2) Associate Membership (1 person)
\$5 1 child, age 10-17 years old	Junior Membership Type (see qualifications in above table)
\$0 1 adult in a house	Honorary Membership Type (see qualifications in above table)
